Assumption of Risks, Responsibility and Liability Waiver

PLEASE READ CAREFULLY

This information will be used for the Jack Webster Foundation’s “Seeing the World Through New Eyes” program (or the “Program”). This information will be used/released in the event of an emergency, as deemed necessary by Jack Webster Foundation. This form is to be completed and returned to the Jack Webster Foundation.

In consideration for being permitted to participate in the Jack Webster Foundation’s “Seeing the World Through New Eyes” program:

Assumption of Risks: I understand and agree that participation in the Jack Webster Foundation “Seeing the World Through New Eyes” program (the Program) will take me away from my home for an extended period of time. During this period, I understand that I will be in an unfamiliar surrounding and will be exposed to known and unknown risks to my person and possessions.

I understand that I may suffer physical injury, sickness or death, or damage to my property as a result of my participation in the Program; and that there is a possibility of violence and crime and civil unrest. I freely and voluntarily accept and assume all such risks, dangers and hazards. Accordingly, I understand and agree that the Jack Webster Foundation, CIDA and Don Cayo bear no responsibility whatsoever for my safety and that I am personally solely responsible at all times for all such risks and dangers to my person and property.

Assumption of Responsibility: I understand and agree that it is my sole responsibility to abide by any and all Canadian, Jack Webster Foundation, CIDA and foreign country policies and laws while travelling to, from or in the host country, and that I have sole responsibility to and must ensure that I have adequate and appropriate medical, personal health, dental and accident insurance coverage, as well as protection of my personal possessions for any known or unknown risks that may befall me. Further I understand and accept that I am solely responsible for obtaining and maintaining any and all insurance against those known and unknown risks.

More particularly, I understand and agree that the Jack Webster Foundation and CIDA and Don Cayo do not carry accident or injury insurance for my benefit. I understand and agree that there are certain matters for which I could be held at fault personally even if my conduct meets the standards of Canadian Law and the policies and procedures of the Jack Webster Foundation and CIDA and even if my conduct would be considered reasonable standard for an individual in my position. In these cases I understand and agree that I will be solely accountable in all respects for my own actions and that neither the Jack Webster Foundation, CIDA, Don Cayo or their respective employees, trustees, agents or assigns shall be liable for, or asked by me to accept the consequences thereof. I further understand and agree that I am not an agent or representative of the Jack Webster Foundation or CIDA or Don Cayo and that I have no power or capacity to bind or make either the Jack Webster Foundation or CIDA or Don Cayo responsible in any way, direct or indirect, for my actions.

I acknowledge that I have been advised by the Jack Webster Foundation and CIDA and Don Cayo of such risks and dangers as well as the need to act in a responsible manner at all times. I have attended pre-departure orientation sessions. My signature below is given freely in order to indicate my understanding of the

acceptance of these realities and in consideration for being permitted by the Jack Webster Foundation or CIDA to participate in the above mentioned Program. I recognize that the Jack Webster Foundation or CIDA will not supervise any of the programs, living arrangements, or extracurricular activities during my participation in the Program. In that respect I have made whatever enquiries or investigations I have thought proper, have had the opportunity to seek independent advice as to those risks and the execution of this agreement, do not rely in any way, direct or indirect on the Jack Webster Foundation or CIDA or Don Cayo.

Liability Waiver: I release and hold harmless the Jack Webster Foundation and CIDA and Don Cayo, their employees and trustees from any and all liability for any and all loss, damage, injury or expense that I or my next of kin may suffer as a result direct or indirect, of my participation in this Program, including, but not limited to, accidents, acts of God, war, civil unrest, sickness, transportation, scheduling, government restrictions or regulations, and any and all expenses which I may incur while participating in the Program.

I understand that this agreement cannot be modified or interpreted except in writing by the Jack Webster Foundation and CIDA and Don Cayo and that no oral modification or interpretation shall be valid. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of death.

I HAVE READ THIS DOCUMENT CAREFULLY AND I ACKNOWLEDGE AND AGREE TO THE PROVISIONS HEREOF. I FURTHER UNDERSTAND AND VOLUNTARILY ACCEPT MY SOLE RESPONSIBILITIES AS HEREIN CONTAINED AND UNDERSTAND THE CONSEQUENCES AND LEGAL EFFECT OF THIS ASSUMPTION OF RISKS, RESPONSIBILITY AND LIABILITY WAIVER.
